I am writing further to your request received by Government Communications and Public Engagement. Your request is for:

Regarding standing offer # SO-GCPE018005 and the B.C. Enhanced Contact List campaign: The business case for the project, the project approval, a description for how the enhanced contact list will be used or has been used, the privacy impact assessment, and the report about the completion of the project.

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety.

Government Communications and Public Engagement noted that the enhanced contact list is a necessary element to conducting Telephone TownHalls (TTH) – a channel that government has used for the ChildCareBC and the CleanBC initiatives. As a discrete element, it essentially serves no purpose – but it is key to making the Telephone TownHalls work. This contact list – which is kept in the hands of the service provider, not government – is used by the provider to program and "broadcast" a series of calls inviting people to participate in a regional or provincial TTH. In this instance, the TTH service provider informed government of the need for this contact list after a service agreement had been reached, so this is basically an addendum to that project. The contact list is licensed for a year at a time, allowing government to make use of it for two major initiatives.
