Records, briefing notes, issues notes, information, reports, memos, and committee minutes regarding the transfer of responsibility of health care for transgender individuals to the Provincial Health Services Authority and Vancouver Coastal Health Authority, which was announced October 30, 2014 in a Ministry News Release; All records (excluding emails) that pertain to: Any agreement(s) between the Ministry and said health authorities regarding transgender health care and gender-reassignment-surgery, Ministry funding agreements with the health authorities, New funds allocated for transgender health, Budgeting allocations for transgender-specific health care and gender-reassignment surgery, Orders by the Ministry to the health authorities regarding funding allocations for transgender health and transgender health care delivery requirements, Securing funds for transgender health care services within existing health authority budgets.
