Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Health. Your request is for:

Copies of the documents that calculate and set out the cost of funding an IMG resident's postgraduate training in each of family medicine, psychiatry, pediatrics, and internal medicine for the years 2011/2012, 2012/2013 and 2013/2014 as set out in the return of service contracts that IMGs sign at Article 3.1.; Documents that set out the amount that has been paid by Health Canada to support the Expansion and Distribution of the IMG-BC Program for Underserved Communities in BC for the year's 2011/12 to date; The accounting for the expenditure of the Health Canada funds if the funds provided by Health Canada are not referenced in the cost of funding an IMG resident's postgraduate training above.

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety. Please be advised that the Ministry does not break down the costs per specialty. The Ministry does not calculate the cost of funding on a per specialty basis, therefore a breakdown for family medicine, pediatrics, psychiatry and internal medicine is not available. For 2011, 2012 and 2013, the RoS contract recovery rate as per Article 3.1 is \$108,000 per year (see attached calculation). For fiscal years 2015/16 and 2016/17, Health Canada did not provide a contribution to support the 'Expansion and Distribution of the IMG-BC Program for Underserved Communities in BC.'
