Please be aware that Provincial Health Services Authority has reported that the number of beds noted in BN 1062583 is not an accurate count. They explained that although 14 enhanced care unit (ECU) beds were approved, the facility they were planned for is not able to accommodate; instead, 20 acute stabilization beds were created for patients that do not require isolation.
