I am writing further to your request received by the Ministry of Aboriginal Relations and Reconciliation. You narrowed your request on February 3, 2017 through email with ANALYST. Your request is for:

My understanding of the Marriage Act (section 2(5)) is that the registrar (ie Vital Statistics) is required to keep a register of all registered religious organizations and representatives. I'm simply asking for a copy of that list (albeit I don't need the names of individual religious representatives), so I'm a bit perplexed by the response that this will take a sizable amount of time. Basically I just want a table with a list of organizations and the corresponding number of representatives (for example, Catholic Archdiocese of Vancouver - 25; United Church, Vancouver - 15).

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety.
