Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Health. You clarified the scope of your request through conversation and email with Lauren Lemieux on March 17, 2017. Your request is for:

Copies of the following: Return of service contracts for all IMGs who matched to UBC Internal Medicine in the IMG Stream in the 2015 and 2016 CaRMS match; Documents which set out the cost of any assessments for each of the IMGs funded by the Ministry including, MCCEE, NAC OSCE, and/or BC-IMG Assessment Program; For each resident physician in Internal Medicine who matched in the 2015 and 2016 CaRMS Match - the costs associated with the Participant's Postgraduate Medical Education, including the Participant's salary and benefits at the rate, and covered by the terms, specified in the Professional Association of Residents of BC (PAR-BC) Agreement - as provided for in paragraph 3 of Schedule 1 of the contract which sum is paid monthly to UBC according to paragraph 4 of Schedule 1 of the contract.

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety. The Ministry has provided the following information to offer additional detail on how this request was responded to:

1. Copies of Article 3 and Schedule 1 have been provided for both years with each year identified at the bottom of the page. As these do not differ by individual, only one copy is provided.

- 2. The Ministry provides funding to the University of British Columbia (UBC) for postgraduate medical education based on a formula; records of actual costs incurred by individual residents are not held by the Ministry but may be available from UBC.
- 3. The Professional Association of Residents in BC sets out the salaries for residents based on their year of residency. This information is available through the Resident Doctors of BC or through Health Employers Association of BC (HEABC).
