I am writing further to your request received by the Ministry of Health. Your request is for:

*Records related to investigations or inquiries of homes (residential addresses) where there exists or may exist a commercial business for pregnant women and newly born children and their mothers - sometimes called a maternity care home/pre and postpartum care home/baby house/birth tourism home; Audits of such homes by Investigations Branch, Eligibility, Compliance and Enforcement Unit; Records, including memos or emails, from public health nurses related to such homes. Limit search to homes in: Vancouver, Burnaby, West Vancouver, District of North Vancouver, City of North Vancouver and Richmond. (Date Range for Record Search: From 01/01/2015 To 09/01/2018).*
