Records - in an electronically accessible spreadsheet if possible – indicating the number of times refugees in BC, including government-assisted, privately sponsored and refugee claimants, accessed healthcare services paid for under MSP, broken down by type of service accessed, by calendar year, by refugee country of origin, and by type of refugee - whether government assisted, privately sponsored or claimants; Costs to provide services to refugees under MSP per year, broken down by type of healthcare service provided. (Date Range for Record Search: From 01/01/2011 To 09/12/2018)
