The Office of the Seniors Advocate has advised the following and provided the enclosed additional letters of March 7 and March 28, 2019, to assist in supplementing your understanding of the issue. Records within this package from Fraser Health (FHA), Vancouver Coastal Health (VCHA), and Vancouver Island Health (VIHA) reference results from analyses conducted by these three health authorities for the purposes of comparing emergency department and hospital transfer rates between contracted and health authority-operated long-term care sites with overall provincial results reported by the Office of the Seniors Advocate (OSA). FHA, VCHA, and VIHA used different selection criteria than were used in the study by the OSA that is the source of the provincial results; therefore, an accurate comparison cannot be made for reasons of selection bias that may exist in the FHA, VCHA, and VIHA analyses.
