I am writing further to your request received by the Ministry of Health. Your request is for:

In order to provide a clear and complete response to your request, I have separated the "[specified] records" noted above into 4 parts, numbered below for ease of reference:

All records, documents, notes and written information of every type, whether paper, electronic or other format, of Adrian Dix as Minister of Health and Adrian Dix as NDP Opposition critic, about or in relation to:

- 1. the 2012 firing of 6 and the constructive dismissal of one Ministry of Health research employees and the Liberal government Ministry of Health internal investigation, decision-making, and reporting to the RCMP and including Adrian Dix' calls for an inquiry;
- 2. the related investigation by the Ombudsperson and the Ombudsperson's report, Misfire: The 2012 Ministry of Health Employment Terminations and Related Matters,
- 3. Adrian Dix' meeting with the terminated employees and any of their family members, and
- 4. the appointment by Adrian Dix, as Minister of Health, of one terminated employee, Ron Mattson, to a Director of the Vancouver Island Health Authority Board.

With respect to part 3 of your request, although a thorough search was conducted, no records were located in response to this part of your request.
