All records regarding the negotiation (including capacity funding and negotiation protocols), drafting, signing and implementation of the Brucejack Economic and Community Development Agreement concluded with the Tahltan Nation for mineral tax revenue collected from the Brucejack Gold Mine in Northwestern British Columbia, as well as all such records that concern the consultation and accommodation assessment of the Tahltan Nation's right to revenue sharing with the province, and the decision to engage in negotiations for such an agreement. (Date Range for Record Search: From 01/01/2012 To 07/03/2018)
