Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Justice, specifically Road Safety BC. Your request is for:

The total number of Immediate Roadside Prohibitions issued in the month of February and March, 2015; Copies of every IRP decision from the month of February and March 2015 in which the prohibition was revoked.

Immediate Roadside Prohibitions (IRPs) are issued by Municipal Police or RCMP. The total number of IRPs processed by Road Safety BC in the month of February 2015 is 1,166 and for March 2015 is 1,284. The number of IRP reviews conducted by Road Safety BC in February 2015 is 231 and in March 2015 is 246. The total number of IRPs overturned, as represented by the enclosed records, for February 2015 is 86 and for March 2015 is 99.

Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to section 22 (Disclosure harmful to personal privacy) of *FOIPPA*. A complete copy of *FOIPPA* is available online at:
