The total number of Immediate Roadside Prohibitions issued in the month of April, 2015; Copies of every IRP decision from the month of April, 2015 in which the prohibition was revoked.

Immediate Roadside Prohibitions (IRPs) are issued by Municipal Police or RCMP. The total number of IRPs processed by Road Safety BC in the month of April 2015 is 1,293. The number of IRP reviews conducted in the same month by Road Safety BC is 256. The total number of IRPs overturned, as represented by the enclosed records, is 105.
