Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Justice (Liquor Control and Licensing Branch). Your request is for:

Records in respect of the number of contraventions of s. 37 of the Liquor Control and Licensing Regulations failure to post liquor license in a conspicuous place which have taken place in the past ten years, of these the number ticketed by peace officers using: a Violation Ticket, using Contravention Notices or other non-Violation Ticket forms; Of the Violation Tickets, the number that went to Court and the number that went to the Branch tribunal; The range of penalties exacted for contraventions of s. 37 of the Liquor Control and Licensing Regulations failure to post liquor license in a conspicuous place. (Date Range for Record Search: From 01/01/2005 To 07/03/2015)

Please find enclosed a copy of the record created in response to your request. It is provided to you in its entirety.

Please note that in 2009 the contravention changed from 'Contravening a term and conditions, s.12 — Liquor licence not posted' to 'Fail to post licence as required, s.37(a) Reg.' The Ministry advises that they do not maintain statistics for contraventions that are noticed but not enforced. Only two contraventions had penalties imposed — one went to an enforcement hearing and the other resulted in a signed waiver.
