***Freedom of Information and Protection of Privacy Act (FOIPPA)***

I am writing further to your request received by the Ministry of Justice, specifically RoadSafety BC. Your request is for:

*The total number of Immediate Roadside Prohibitions (IRPs) issued in the months of June, July and August 2015; Copies of every IRP decision from the months of June, July and August 2015 in which prohibition was revoked.*

Please note that Immediate Roadside Prohibitions (IRPs) are not issued by RoadSafety BC, but by the Municipal Police or the RCMP. RoadSafety BC processes IRPs for revocation. The total number of IRPs processed by RoadSafety BC for revocation in the month of June 2015 is 1,327, for the month of July 2015 is 1,499, and for the month of August 2015 is 1,478.


