Records regarding the evidence upon which the decision to compel drivers 80, 82, 84, etc. to be retested is based on including what statistical reports showed that drivers decline so rapidly from 80 to 82, from 82 to 84, etc. and how the ministry's evidence compares with the statistical evidence used by insurance companies such as ICBC allowing senior drivers reduced insurance rates as compared to younger drivers.
