Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Justice. Your request is for:

Current security guard contracts with the Ministry of Justice and the Courts including: Wages/bill rates, all changes/addendum, a copy of all evaluation documentation from the previous procurement, and a copy of the winning proposal from the previous procurement.

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety.

The first document in your package is the Request for Qualifications for Security Services (RFQ no. CRSD2015-001). The purpose of this RFQ was to establish a qualified suppliers list for Security Services. This list currently consists of the following companies: G4S, Lionsgate Security, Paladin, Secureguard, Tesseract Security, and Xpera Risk Services. The amounts paid to these companies in fiscal year 2016/17 are as follows:

The second document in your package is the Request for Proposal for Sussex Building Security Guard Services. The successful proponent was Paladin.

The Ministry advises that security guard contracts for BC courts are part of the service contract between the Ministry of Technology, Innovation and Citizen Services (MTICS) and BrookfieldGIS - WSI. This contract lists services such as cleaning, security, landscaping, etc. and outlines the procurement guidelines for contracting out such services. While MTICS has custody of the overall service contract with BrookfieldGIS - WSI, they do not have custody or control of the subcontracts between BrookfieldGIS - WSI and other service providers.

All attempts have been made to provide you with the most readable copy, however, you may find some of the records are in poor condition. Your file is now closed.
