Removal of LNG Income Tax) of a new framework as outlined in the March 22, 2018 government news release in Backgrounder 2 titled, "British Columbia establishes new framework for natural gas development." Restrict search to the executive offices of Assistant Deputy Ministers and above. (Date Range for Record Search: From 07/01/2018 To 10/31/2018)
