I am writing further to your request received by the Ministry of Labour. Your request is for:

All records and communications – including emails (sent and received; excluding TNOs; exclude attachments), text messages, slack messages, WhatsApp messages, and/or other SMS/messaging applications' communications – and documents related to the reported direction from the Minister of Finance to all ministries to “begin examining discretionary spending in budget to look for savings that can be put into contingencies” (Times Colonist - September 26, 2019) including but not limited to travel, consulting contracts, and office expenses. Restrict search to Minister's Offices and Deputy Minister's Offices. (Date Range for Record Search: From 09/01/2019 To 10/11/2019)
