Liquor Distribution Branch: All records in the possession of BCLDB and/or the Ministry pertaining to the Contract including, but not limited to, the bid documents submitted by Brains II, correspondence between BCLDB and/or the Ministry and Brains II regarding the Contract and Brains II's bid for the same; All records in the possession of BCLDB and/or the Ministry relating to Brains II's performance under the Contract including but not limited to correspondence, memorandums, notes, or other documents. (Date Range for Record Search: From 03/31/2015 To 09/25/2017)

On May 21, 2019 the OIPC issued an order F19-23 indicating "the Ministry is not required to refuse to disclose the information at issue to the applicant under s.21(1)(c) of FOIPPA. The Ministry is required to give the applicant access to this information by July 3, 2019.
