Some information has been withheld in the enclosed records pursuant to sections 12 (Cabinet and local public body confidences), 13 (Policy advice or recommendations), 16 (Disclosure harmful to intergovernmental relations or negotiations), 17 (Disclosure harmful to the financial or economic interests of a public body), and 22 (Disclosure harmful to personal privacy) of FOIPPA. Please be advised that certain records have been withheld in their entirety, pursuant to section 14 (Legal advice).

Information that is a court record, a record of a judge of the Court of Appeal, Supreme Court or Provincial Court, a record of a master of the Supreme Court, a record of a justice of the peace, a judicial administration record or a record relating to support services provided to the judges of those courts has been removed pursuant to section 3(1)(a) of FOIPPA.
