Regarding A-G Eby's statements to the House of Commons finance committee in Ottawa on March 27, 2018, that suspicious cash transactions at B.C. casinos had decreased from \$20 million in July 2015 to \$200,000 in February 2018, the copy of the briefing note and the report that were the basis for those statements.
