What recourse AND appeals are available if someone disagrees with a decision in response to their complaint? What policy/procedures are in place to deal with disciplinary or corrective measures around complaints against a BC Sheriff or the BC Sheriff's office? What does this involve? Any data in relations to: type of complaints; location of where the incident took place; how many complaints has been received from; the public; someone detained; internal staff and from the ministry, this list is not exhaustive to the above noted list.
