*Any records concerning or briefing notes provided to the Minister or Deputy Minister, regarding a planned RCMP police operation to raid suspected underground casino locations in Richmond, on or about October 14, 2015, including any communication on the plan or warrant information for the police operation, before the date, and after the date, results of the operation, and whether the operation was compromised in any way, and suspected underground casino had been abandoned at the time of the raid. (Date Range for Record Search: From 07/01/2015 To 12/25/2015)*
