A copy of any and all policy or policies of the government of the Province of British Columbia that in any way relate(s) to or refer(s) in any manner to the issue of solicitor-client privilege; A copy of any and all "policies" developed by the Crown in right of British Columbia regarding waiver of solicitor-client privilege including all records and communications relating to or documenting any and all practices of the Crown in right of British Columbia with respect to solicitor-client privilege; A copy of any policy, including any "overall" policy regarding solicitor-client privilege between the Ministry of Justice and/or Attorney General and any client Ministry, including any and all policy or policies that relate to FOIPPA responses or cases involving litigation as well as any and all policies that relate to situations or circumstances that do not relate to FOIPPA responses or cases involving litigation; A copy of any and all reports relating to the policies and procedures of the government of the Province of British Columbia or the BC Attorney General's Department or Ministry of Justice in relation to solicitor-client privilege.
