A copy of any and all policy or policies in full of the government BC that refer to or reference in any way to the matter of solicitor-client privilege, as well as a copy of any and all procedure(s) and/or policies presently in use or in process of being developed to be in use by the BC crown in right referencing or referring to in any way, the waiver of solicitor-client privilege; Any and all general and/or overall policies with respect to solicitor-client privilege between the Ministry of Justice and/or the Attorney General and various client Ministries, such as but not limited to the Ministry for Children and Family Development and Public Safety and Solicitor General, including any and all policies that reference and/or relate to responses to requests through the FOIPPA or cases involving civil litigation; A copy of all records referencing or referring to or otherwise related to the policies as well as procedures of the government of BC and/or the Ministry of Justice relating to solicitor-client privilege that are currently in use or are being developed to be in use as well as any records referencing or referring to reviews of these policies or procedures concerning solicitor-client privilege and as well as the waiver of solicitor-client privilege.
