I am not requesting records on specific MSBs. (Date Range for Record Search: From 01/01/2018 To 12/12/2018)

As per your agreement with Samara Fisher on January 16, 2019, all but the final copy of the documents prepared for Cabinet have been removed from the response package.

During our consultation with BC Lottery Corporation, they requested we provide you with information regarding the first bullet in their briefing note on page 22 of the records. They have advised that the last part of the bullet should read "...BCLC creates a Large Cash transaction report for internal record keeping purposes in order to track PGF account withdrawals."
