Records of any and all emails, text messages, BBMs, slack messages, and WhatsApp messages - excluding attachments – sent from the Minister's Senior Ministerial Assistant(s) - where such a position existed and was staffed during the period (Date Range for Record Search: From 01/01/2019 To 01/31/2019)

The records located in response to your request will be delivered through the BC Secure File Transfer Service. Separate emails will follow from the BC SFT Notification Service directing you how to set up an account and where to obtain your records. Some information has been withheld pursuant to section(s) 12 (Cabinet and local public body confidences), 13 (Policy advice or recommendations), 14 (Legal advice), 15 (Disclosure harmful to law enforcement), 17 (Disclosure harmful to the financial or economic interests of a public body) and 22 (Disclosure harmful to personal privacy) of FOIPPA. Additionally, information was removed that is not subject to FOIPPA pursuant to section 3 (Scope of this Act) (h) a record relating to a prosecution if all proceedings in respect of the prosecution have not been completed.
