Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Attorney General (Liquor Distribution Branch). Your request is for:

Records of the total amount of online and in-store sales of cannabis in BC since Oct. 17, 2018, broken down by region. (Date Range for Record Search: From 10/17/2018 To 05/28/2019)

BC Cannabis Stores launched October 17, 2018 with the online store bccannabisstores.com and one BCCS retail store in Kamloops, which, at present, is the only BCCS retail outlet in operation. BCCS remains a start-up retail operation in a highly competitive mixed private/public market with a significant number of direct competitors currently in start-up phase as well. In responding to your FOI request, we carefully considered the application of section 17 and relevant factors weighing in favour of, and against, release of cannabis sales information.

Section 10 of the <u>Cannabis Distribution Act</u> sets out the Liquor Distribution Branch (LDB)'s reporting requirements to Government in the form of an Annual Report, which the Minister is required to lay before the Legislative Assembly prior to its being made available to the public. At the time of this writing LDB has not yet reported its first fiscal year of cannabis financial information to Government. The LDB does not release monetary sales figures for its BC Cannabis Store in Kamloops and its online store. Since the lone retail location operates in a mixed private/public retail model, sales amounts for it, as well as the online store, are considered competitive information and are not released outside of the LDB's Annual Report, which will provide the combined sales for its BC Cannabis Store and online store. The LDB's 2018/19 Annual Report is expected to be available in August. Its 2017/18 Annual Report can be found here:

The LDB values transparency and makes a significant amount of liquor sales data available through reports which can be purchased through our External Data Services team. Sales data for individual stores is not released publicly, nor sold. In future, a robust cannabis sales dataset will allow for similar financial and related reports to be made available.

Your FOI request is now closed.
