I am writing further to your request received by the Ministry of Municipal Affairs and Housing. Your request is for:

All records including financial data related to the initial offer from the Ministry of Transportation and Infrastructure as written in the SSI Incorporation Study Report on page 167 which read, 'Complete resurfacing of approximately 13 km of Fulford Ganges Road, including a 1.2 meter shoulder on both sides of the road (estimated at \$5 million)' and 'MoTI will accelerate the resurfacing of Fulford Ganges Road, which was outside of its five year rehabilitation plan'; All records including financial data related to the statement in the email from Marijke Edmondson to Peter Lamb on Monday, June 26, 2017 wherein she wrote, 'Thank you for your email of last week, seeking clarification regarding the capital aspects of the MoTI restructure assistance offer. We have confirmed with colleagues at MoTI that their Ministry would carry out the improvements themselves and therefore pay actual costs'.
