A copy of invoices for the purchase of toner for legacy printers outside the Managed Print Services. (Date Range for Record Search: From 01/01/2014 To 12/31/2014)

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety. As you are aware, the attached records represent only those transactions where toner was singled out in the data entry process as being part of the invoice purchase/transaction. If the AP clerk did not identify toner as part of the invoice or the toner was covered by a more general term (i.e. supplies), it would not have been identified.
