Copy of all records with respect to environmental issues and use of Lot 17 Nordic Estates DL4978 (now known as 2077 Garibaldi Way, Whistler) and Lot 3 DL5412, including the relationship of these two lots to each other and to a private road that was previously designated as access to Lot 3 DL5412 from the Aspen Ridge strata DL5413 but was changed to a private road thus stopping access to Lot 3 DL5412, and any records regarding any relationship of these issues to Lot 18 DL4978 re Crown Grants applied for and/or granted and access issues - all these District Lots being in Whistler. Reference Crown Grants L31150 and P75803 (Date Range for Record Search: From 01/01/1970 To 08/03/2018)
