I am writing further to your request received by the Ministry of Environment and Climate Change Strategy. Your request is for:

A complete copy of the following, including all amendment, modification, supplement, restatement, novation and/or replacement of any of these documents regarding permits issued in EC Manning Park: Park Use Permits of type "Land use/occupancy only; Application forms for each land use/occupancy park use permit; Policies, guidelines and written criteria with regard to the issuance of those permits; Assessments and decision documents about the permits from regional BC Parks staff, supervisors and directors as well as the Minister or Deputy Ministers of Environment; Emails between Ministries about the permits; All communication documents from the permittees corresponding to their respective park use permits – exclude documents about Park Use Permits for commercial recreation, research or film activities. (Date Range for Record Search: From 01/01/2003 To 12/31/2004)
