Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Social Development and Social Innovation. Your request is for:

Relating to the Food Crisis Supplement of \$20.00 per month per person: Statistical records that necessarily would have to be in place in some format for accounting and recording keeping purposes. Timeframe is: 2013, 2014, 2015.

Although a thorough search was conducted, no records were located in response to your request. The Ministry did not locate records as there have been no statistical records created. However, the Ministry offers the following information and table in response to your request:

A crisis supplement may be provided to income assistance and disability assistance recipients who face unexpected emergency needs. The crisis supplement may be provided if all of the following apply:

- The supplement is needed to meet an unexpected expense or need.
- Applicants cannot meet the expense or get a needed item because there are no resources available.
- Failure to meet the expense or get the needed item will result in imminent danger to the physical health of applicants or the removal of a child under the *Child*, *Family and Community Service Act*.

A crisis supplement is meant to help an income assistance client only in an emergency when all other resources have been exhausted. It cannot be used to support an ongoing situation or as a way to provide assistance that is prohibited by other regulations. For more information on crisis supplements please visit:
