I am writing further to your request received by the BC Coroners Service. Your request is for:

*Information related to the number of suicides that have occurred on the Mission/Abbotsford Bridge since 2000. (Date Range for Record Search: From 01/01/2000 To 04/13/2018)*

Below please find the statistics identified in response to your request. This data is provided to you in its entirety.

The BC Coroners Service was able to identify 5 suicide cases where the location of injury was the Mission Bridge/Railway Bridge. Please note that data from 2013 forward is more accurate as the name of the bridge may not be available for previous years. The data for 2017/2018 is subject to change as coroner's investigations are concluded.

2013 – 1 case Mission Bridge, 1 case Mission Railway Bridge  
2015 – 1 case Mission Bridge  
2017 – 2 cases Mission Bridge
