BC Coroners Service records on the number of suicides that have occurred in the Fraser Health region broken down by municipality, sex and age. (Date Range for Record Search: From 06/25/2009 To 06/25/2019)

Below please find the data tables created in response to your request. These records are provided to you in their entirety. Please contact Andy.Watson@gov.bc.ca from the BC Coroners Service to provide context for the 2018/2019 numbers as they are considered incomplete due to cases still under investigation.

Fraser Health Suicide Deaths

The data includes all deaths classified as suicide between June 25, 2009 and June 25, 2019 in the Fraser Health Authority region. Suicide is defined as death resulting from self-inflicted injury, with the intent to cause death.

Data Limitation

*Please note that the 2018 and 2019 data represent completed investigations only. The data for these years is incomplete and the numbers will change as further investigations are completed for those years.
