I am writing further to your request received by the BC Coroners Service. Your request is for:

A list of deaths at registered Mental Health and Substance Use Assisted Living residences between Jan. 1, 2017 and Nov. 30, 2019, including the number of deaths, dates of those deaths and addresses where the deaths occurred. If available, the list should include the causes of death and times between the deaths and when they were reported to the Assisted Living Registrar.
