Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the BC Coroners Service (BCCS). Your request is for:

Regarding the BC Coroner's Office: All policies and procedures related to who is allowed or prohibited from being present in the room where an autopsy or post-mortem is being conducted, apart from the coroner. (Date Range for Record Search: From 1/1/2018 To 7/21/2021)

The BCCS provided the policy outlined below:

As the autopsy occurs under the authority of the Coroner, only those individuals authorized by the Coroner may attend the autopsy. In suspicious deaths this is limited to the designated police representatives, pathologist, a pathology assistant, or another expert approved by the Coroner. A coroner may also be requested to attend an autopsy being conducted by a non BCCS pathologist, at the discretion of the Unit Director.

Your file is now closed.
