Any records pertaining to: The disposal of the provincial Jericho lands; The negotiation of the disposal of the provincial Jericho lands between the Crown in right of the Province of BC including the Ministry of Technology, Innovation and Citizens' services and the interested First Nations including the Musqueam, the Tsleil-Waututh and the Squamish; The Conseil scolaire francophone de la Colombie-Britannque, School Distrist 93 regarding the provincial Jericho lands; The potential uses or the future disposal of the provincial Jericho lands including a study conducted by Coriolis Consulting Corporation titled Evaluation of the Development Potential of the Provincial Jericho Lands prepared for Altus Group, including a draft report dated on or about October 2012 and other draft and final versions of the study or any other studies, reports or records; Discussing or commenting upon parties private or public interested in the acquisition or use of the provincial Jericho lands; The disposal of or the future use of the provincial Jericho lands between the MTICS and the Ministry of Education.
