Regarding the \$4.9 million compensation fund established for 98 children of missing and murdered women, pursuant to the recommendation made by the MWCI in 2012 and implemented by the Ministry of Justice in March 2014: Any records, including but not limited to, internal reports, briefing notes, and spreadsheets—specifically, data or reports that determine, and have tracked, how many children applied for compensation, when they received it, and how much they received, how many children are currently in the process of applying. Exclude personal information. (Date Range for Record Search: From 04/01/2014 To 02/05/2016)
