Any crisis management exercises developed for the Corrections branch by the Justice Institute for staff training and development purposes over the last 2 years. (Date Range for Record Search: From 01/01/2015 To 06/12/2017)

Corrections BC advises that the Justice Institute of BC (JIBC) does not develop the crisis management exercises; they are developed by the correctional centres' Deputy Wardens of Operations. Additionally, the JIBC facilitator advises that incident command system exercise outlines will vary in format and detail depending on the nature of the scenario used. An outline is generally used as a starting point to facilitate the exercise. Once a scenario begins it will

develop depending on how the event is managed. This aspect of the exercise is not captured in the outline. Your file is now closed.
