Regarding driving prohibitions under Section 93 of the Motor Vehicle Act and the Driver Improvement Program (DIP) policies and guidelines, a summary document or records indicating: Number of drivers who were prohibited from driving without relying on DIP - i.e. by exercising The Superintendent of Motor Vehicles' discretion; Number of drivers who were prohibited from driving in reliance upon the guidelines in DIP; Number of drivers who were prohibited from driving under Section 4.2 of DIP because of having committed any combination of two or more of the five offences within a one year period other than that specified in the next item following; Number of drivers who were prohibited from driving under Section 4.2 of DIP because of having committed one of the five offences within a one year period for two or more times; Number of hearings held under Section 93(1) of the Motor Vehicle Act before drivers were prohibited from driving.
