I am writing further to your request received by the Ministry of Public Safety and Solicitor General. Your request is for:

Regarding MOUs or contracts mentioned under the 'Referrals' section in the Crown Counsel Policy Manual related to Alternative Measures for Adult Offenders (55360-00; ALT-1): A copy of the Adult Alternative Measures MOU between the Corrections Branch and the Criminal Justice Branch; A summary document indicating the name of the agency and the alternative measure service they provide for agencies contracted by the Corrections Branch to provide alternative measures services. (Date Range for Record Search: From 10/12/2010 To 02/17/2018)

Please find enclosed a copy of the 2002 Memorandum of Understanding (MOU) between the Corrections Branch and Criminal Justice Branch. The 2002 MOU remains current and is provided to you in its entirety. The Ministry advises that, while contracts are with the Corrections Branch, they are signed at a regional level and managed at a local level. A summary document cannot be created in response to your FOI request without unreasonably interfering with the Branch's day to day operations, as creation of such a document would entail collecting and compiling information from the 55 probation offices across the province.

Your file is now closed.
