Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Public Safety and Solicitor General. Your request is for:

Records showing how many inmates were released from Kamloops regional correctional centre and dropped into the city of Kamloops in the years 2019, 2020, and 2021; Along with details on how many of the total inmates released during those years were Kamloops residents and non-Kamloops residents. (Date Range for Record Search: From 1/1/2019 To 12/31/2021)

With respect to how many individuals were released from Kamloops Regional Correctional Centre (KRCC) between 2019 and 2021 into the community, we can advise that 818 individuals were released in 2019; 553 individuals were released in 2020; and 439 individuals were released in 2021. Please note these figures may include individuals who were admitted and then released more than once per year.

While the residence is noted on an individual's file upon admission, BC Corrections business intelligence system is unable to aggregate this data. Upon release, BC Corrections, at minimum, is mandated to provide individuals with transportation back to the community where their court matter originated. Information on the court of origin for admissions into KRCC between 2019 and 2021 is as follows:

Court of origin refers to the court that issued the most recent warrant for an individual in custody at KRCC. Note that most of the time, *though not all of the time*, court documents are issued where the offence took place. As such, these data should be interpreted with caution.
