I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

All records that pertain to the work that was conducted at or near 3 kilometres South of Old Hasler Road on Highway 97 North, approximately 30 kilometres South of Chetwynd, BC; Information about the contractors who were working on the Site; Any documentation such as contracts which make evident which parties were working, operating, managing or responsible for the work conducted at the Site; Any and all documents which relate to the particular incident that occurred on October 11, 2012 at the Site.
