I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

Reports, analysis and plans for the traffic lights at redesigned signalized intersections on Highway 17 from edge of BC Ferry Causeway to past 56th St., Delta towards 28th Ave overpass, specifically the timings and any reports such as Bunt Report (2012) to Tsawwassen First Nation, which MOTI has declined to share/release. (Date Range for Record Search: From 08/01/2011 To 09/01/2015)

While portions of the traffic impact report are being withheld at the request of the Tsawwassen First Nation, ministry wants to advise the applicant that ministry traffic engineers reviewed and accepted the traffic projections contained within the report. Ministry engineers are satisfied that the highway improvements constructed by TFN and traffic signal adjustments accepted by the Ministry will result in levels of service equal to or better than those pre-development. Specific signal timing plans were also developed to ensure smooth flow while ferry offloading.
