I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

Documents that provide background information on the South Fraser Perimeter Road Concession Agreement Amendment Agreement, as authorized through Orders in Council 2015-525 and 526, approved and ordered on September 18, 2015, including any and all briefing notes, decision notes or other documents that were provided to the Deputy Minister, the Minister and Cabinet. (Date Range for Record Search: From 06/01/2015 To 09/21/2015)

The requester should note that the SFPR Concessionaire refinancing transaction was settled in October 2015 after the date range for this FOI. The final provincial share of the refinancing gain at financial close was \$15.1M to be deducted from monthly payments over the remaining term of the Concessionaire Agreement.
