Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Transportation and Infrastructure. You narrowed your request on May 4, 2016 through conversation and/or email with me. Your request is for:

A summary document indicating annual number of inspections and audits performed by the Commercial Vehicle Safety and Enforcement branch including the results of inspections and audits for the years 2011, 2012, 2013, 2014, and 2015.

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety.

The Ministry would like to provide the below additional information regarding your request and the records you have received;

- Crashes involving commercial trucks on B.C. highways are down by 23 per cent since 2005. Over the last year, CVSE has focused on educating companies on NSC requirements and best safety practices.
- Three years ago the ministry introduced compliance audits as a way of quickly assessing a company and providing direction to achieving NSC compliance. As such, the number of full audits has been declining while the number of compliance reviews has been increasing.
- Every year, CVSE looks at hundreds of thousands of commercial vehicles that cross our weigh scales and inspection sites across the province. Of these, the ministry targets more than 25,000 vehicles a year for closer inspections.
