In respect of your request for a second review consultant's report about the feasibility of the E&N track upgrade plan, submitted to the Ministry, likely in September, 2015, no report exists, however there was a review done by the Island Corridor Foundation and Southern Railway of British Columbia of the first report. That review has been included in response to this request.

In respect of your request for a report prepared by Hatch Mott MacDonald for the Ministry regarding a review of the BC Safety Authority and its capacity to evaluate rail track and rail safety - either generally or specifically in relation to the E&N rail line, the ministry has no responsive records.
