I am writing further to your request received by the Ministry of Transportation and Infrastructure. You narrowed your request on April 27, 2016 through conversation and/or email with Elizabeth Babecy. Your request is for:

Records related to the Ministry of Transportation and Infrastructure's review of the E & N Railway line on Vancouver Island (the "E & N Railway") as it pertains to a \$7 million funding commitment for the railway made in 2011 and renewed in 2015. Records, reports, memorandums, and correspondence related to the cessation of passenger service on the E & N Railway in 2011 and freight services in 2014. Records, internal memorandums, and correspondence related to plans for the E & N Railway after passengers services ceased in 2011 and freight services ceased in 2014. Reports on the condition of the E & N Railway from 1996 to the present, including the report authored by Alberto Simoes of RTC Rail Solutions Ltd. Please exclude drafts and include emails.
